# **Lithium Valley Warranty Terms (Overseas)**

Shenzhen Lithium Valley Technology Co., Ltd(Hereinafter referred to as the "Lithium Valley") Product Warranty Terms

Lithium Valley offers standard factory warranty which is valid 10 years for battery products, from the date of installation or no more than 10 and a half years from the delivery date from factory.

Batteries operation and storage conditions are as below.

- The charge/discharge rate is no more than 0.7C.
- Operation environment temperature range is between 0  $^{\circ}$ C to 45 $^{\circ}$ C .
- The goods storage environment temperature range is between -35°C to 35°C, the humidity is 65%±20%.
- Recharge battery every six months, and SOC is no less than 30% when store.
- Recharge battery within 10 days after battery is fully discharged.
- High voltage batteries need to be the same batch batteries when install. When different batch batteries are
  installed in the same system, all batteries need to be balanced to the same voltage by individual charge and
  discharge.

## 1. Product Quality Standards and Warranty

- 1. 1 Lithium Valley batteries comply with safety transportation related to UN38.3 and MSDS.
- 1.2 The battery warranty is decided by Lithium Valley and it's distributor.
- 1.3 After the products left factory, the appearance damage (scratches, rust, chemical damage) is beyond warranty.

### 2. Warranty Exceptions

- 2. 1 Damage or lose to battery or accessory caused by logistics.
- 2.2 Battery failure caused by non-compliance inverters or chargers which lead to e.g. abnormal charge voltage, unqualified inverter or charger.
- 2.3 Battery malfunction or damage caused by non-professional or non-qualified personnel.
- 2.4 Failure to observe the user manual, the installation guide, and the maintenance regulations.
- 2.5 Change or remove specification label, serial number (SN).
- 2.6 Product malfunction or damage due to disobey to relevant laws and regulations or technical requirements in power plant design, construction, or installation works.
- 2.7 Connect high voltage inverter to low voltage battery or connect low voltage inverter to high voltage battery.
- 2.8 Product malfunction or damage due to installation on movable device or in vibration occasions.
- 2.9 Failure or damage caused by corrosion, lightning and other natural damage or force majeure.
- 2. 10 Unauthorized alteration or disassembly of the product.
- 11 Damage or malfunction caused by other facilities e.g. Surge damage caused by switching on/off high power generator.

### 3. Repair and Replacement

3. 1 When a failure occurs, the user should check and record from the screen display the error code, protection

values and necessary information.

- 3.2 When the dealer or Lithium Valley confirmed that is the product quality problem, the faulty product will be repaired and replaced by spares.
- 3.3 Lithium Valley is only responsible for the company's products troubleshooting, repair and replacement, but doesn't assume any other special damages, consequential damages, incidental damages (including loss of profits, loss of goodwill, loss of business reputation loss or delay, etc.).
- 3.4 This warranty does not affect the customer's enjoyment of any other rights laws and regulations relating to sales of consumer goods provided for in the host country or region.
